*¹ In Belgium, the regulations for registering foals have been changed since 2024. Herewith we would like to inform you about the procedure for registering foals in Belgium. This is because it is compulsory for Belgian foals to be chipped and sketched by veterinarians. This can only be put into effect if the Oldenburg studbook passes on complete information to the BCP.

All foals must be registered according to the rules implemented by the BCP (Belgian confederation of the horse) on behalf of the Belgian Ministry of Agriculture. In doing so, all Oldenburg foals born in Belgium must be included in the "HorseID" database.

For this, we have an agreement with BCP and it has the following steps:

1. The Oldenburg Studbook provides BCP with a file containing the foal's life number, sex, date of birth and parentage data (from the normal birth notification) plus:
 - a. **Establishment number** (code for the location),
 - b. **ID BCP number**,
 - c. **Identifier number**. Please send us the **name of your veterinarian**.

For all foals of Belgian breeders, we require these three numbers and the birth notification to be sent by email to: kathmann.carolin@oldenburger-pferde.com
