- Presentation under the own rider with evaluation of the basic gaits/External rider test
- Presentation in the ring at walk in hand with announcement of the entry/award

Please note!

- Each mare owner has to follow the given order. The mares will be presented by head number to ensure a smooth process in the interest of all.
- Please hand in your mare's passport to the registration team before the test. We need to take it to the office to enter the studbook status and the premium.
- The mares are not allowed to wear bandages/boots at the marebook inspection and at the presentation under the rider, but bandages/boots are allowed in the front at free jumping.
- Any liability for accidents or damage of any kind to persons, animals or objects will not be accepted by the association as organiser. Injuries or illnesses of the mares presented for the test, as well as damage or accidents caused during the event are the sole responsibility of the owners.
